QUESTION 1: In Section 1.4 System requires 2 redundant session border controllers (SBC):

these are typically part of the ESInet and provided by the network service provider. Are you
requesting 2 onsite SBC's or just interoperability with the Telus network SBCs?

ANSWER 1: Yes, we are requesting session border controllers onsite. The session border controllers in the PSAPS have been mandated by the CRTC as part of the NG9-1-1 Onboarding process with TELUS and the new NG9-1-1 Agreements that will be coming out soon.
