Answer 1: The **Quarterly Rate** is to represent the average cost of all maintenance services required to meet regulatory compliance on a quarterly basis. These costs must also be reflected in the **Summary Table**.

Costs associated with **Annual** (once per year) and **Semi-Annual** (twice per year) maintenance activities must be identified and listed separately in the **Summary Table**.

The Regional District requires these costs to be clearly itemized to ensure transparency in billing, particularly during the periods when annual or semi-annual services are delivered and invoiced.
