

**Proposal:** An application has been made for a Zoning Bylaw amendment to allow general store use to be established on the subject property.

Zoning Amendment Bylaw No. 3393, 2025 proposes to amend the Rural 3 (Ru3) zone on a site-specific basis to permit General Store use. Additionally, it will restrict the maximum total floor area used for General Store use to 500.0m2.
